

### **Permission to Play Procedure when both clubs are within County Galway**

1. The player requesting the permission to play completes and submits the online form by 5-00pm on Friday March 6th, 2026.
2. The application is then validated by the Competitions Control Committee (CCC). Forms not fully completed or containing incorrect information are invalid and will not be considered.
3. The Club of the Member seeking Permission to Play is then notified and its observations shall be considered if received within seven (7) days of notification.
4. A Club failing to so reply in writing, within seven (7) days will be deemed to have consented to the relevant Application.
5. If requested by any party involved, the CCC shall give the applicant and the two Clubs concerned the opportunity of attending a convened hearing to outline their respective positions on the application. The CCC at its own volition may convene a hearing and in such a case shall give the applicant and the two Clubs concerned the opportunity of attending the hearing to outline their respective positions on the application.
6. If required, the hearing takes place.
7. The CCC makes its decision in accordance with Rule, Code and County ByeLaw.
8. All parties are notified of the decision by the CCC

## **Nós Imeachta cead imirthe nuair atá an dá chumann laistigh de Chontae na Gaillimhe**

1. Comhlánaíonn agus seolann an t-imreoir atá ag iarraidh an cead imirthe an fhoirm ar líne roimh 5-00pm Dé hAoine 1 Márta, 2024.
2. Déanann an Coiste Rialaithe Comórtas (CCC) an t-iarratas a bhailíochtú ansin. Tá foirmeacha nach bhfuil comhlánaithe go hiomlán nó ina bhfuil eolas mícheart, neamhbhailí, agus ní bhreithneofar iad.
3. Tugtar fógra ansin do chumann an té atá ag lorg an cead imirthe agus déanfar a bharúlacha a mheas má fhaightear iad laistigh de sheacht (7) lá ón bhfógra. Mura dtugann cumann freagra i scríbhinn laistigh de sheacht (7) lá, measfar gur thoiligh sé leis an iarratas ábhartha.
4. Má iarrann aon pháirtí lena mbaineann é, tabharfaidh an CCC deis don iarratasóir agus don dá chumann lena mbaineann freastal ar éisteacht a thionólfar chun a seasaimh faoi seach ar an iarratas a leagan amach. Féadfaidh an CCC as a stuaim féin éisteacht a chomóradh agus i gcás den sórt sin tabharfaidh sé deis don iarratasóir agus don dá chumann lena mbaineann freastal ar an éisteacht lena seasaimh faoi seach ar an iarratas a leagan amach.
5. Más gá, tarlaíonn an éisteacht.
6. Déanann an CCC a chinneadh de réir Rial, Cód agus Fodhlí an Chontae.
7. Cuireann an CCC gach páirtí in iúl faoin gcinneadh
